#### **New Fence Paint Supplier**

The Board has identified Home Depot as a new source for purchasing fence paint in Arbor Village. The previous fence paint from Parker Paint (Almond #5731W) has become obsolete and difficult to obtain.

A sample of the Almond paint was taken to Home Depot and they were able to match the color. Below are the numbers for ordering fence paint:

- ♦ 5 gallon = 4722101890
- ♦ 1 gallon = 4722101888
- ♦ 1 quart = 4722101889

#### Remedy for Sidewalk Weeds

Weeds growing up through the sidewalk cracks really detracts from the beauty of your neatly manicured lawn. You could use chemicals, like Round-Up, to get rid of them, but some people may prefer a non-toxic method of weed control.

Here are some super-simple, NATURAL and organic solutions to this weed problem.

- ◆ Get a large gallon jug of distilled white vinegar. Pour the vinegar (undiluted) straight on the sidewalk weeds. Be sure to leave the vinegar on the weeds, do not rinse away. Within two days, the sidewalk weeds will be dead and ready to be removed. Scrape the dead weeds out of the cracks with a long screwdriver or other flat surfaced tool.
- ◆ Take a 1/2 cup of salt to one quart of boiling water and mix well. Once the salt has completely dissolved, pour the contents on the sidewalk weeds for an immediate result.

Once you have killed the sidewalk weeds, preventing them from coming back is just as easy. Take regular table salt or baking soda and sprinkle on the area where the sidewalk weeds were once alive. Repeat this process once a month for clean sidewalk cracks.
